


Sleep Apnea?

Obstructive sleep apnea (OSA) is the term for when the airway collapses, either partially or fully, while someone is asleep. This limits or blocks the ability for air to flow into the lungs. As the person continues to try and breathe, the airway constricts, no matter how hard they try to keep breathing. Once this happens, the person will change the position of their tongue and jaw so that the airway is now open. This usually is followed by the person gasping or snorting. Finally, the person affected will begin this process again.



The effects of this are harmful. It not only makes it harder to breathe, which can be dangerous, but it also leads to less restful sleep. When the airways constrict, the brain “awakens” the person so that they are sleeping more lightly. Spurts of gasping and snorting can repeat hundreds of times throughout the night, disrupting sleep all around.

Dr. Kevin Mangelson is a graduate of Boise State University and Tufts University School of Dental Medicine. Dr Mangelson has been working with TMJ disorders and dental sleep medicine patients since 2008. During that time he spent three and a half years in active duty service for the United States Army as a general dentist. CPT Mangelson spent much of his time treating members of our Armed Forces for TMJ disorders and Sleep Apnea. CPT Mangelson is decorated with the Army Achievement Medical and twice with the Army Commendation Medal for exemplary service to the United States Army. Dr. Mangelson has had the privilege of being personally mentored by world renowned experts in craniofacial pain, pain management, and sleep disorders. His passion for TMJ disorders and dental sleep medicine has motivated him to seek out extensive CE to further his expertise. 

GEORGIA BOARD *of* DENTISTRY

Georgia Board of Dentistry – License Renewal Requirements

As of 1/1/2023

- 🕒 Un-Renewed license expire at the end of odd numbered years.
- 🕒 Georgia runs on a two-year Renewal Cycle
- 🕒 Dentists at all times shall have current certification of CPR
- 🕒 Dentists must have 40 hours minimum of Continuing Education Credits Hours by the end of each 2-year cycle. *(Must Keep record of CE's for 3 years after period ends)*
- 🕒 Below are Approved Governing Bodies that CE Hours may come from that count toward CE hours for licensure:
 - American Dental Association (ADA)
 - Academy of General Dentistry (AGD) – Pace Education Council
 - National Dental Associates (NDA) and affiliates
 - Colleges, and universities and institutions with programs in dentistry and dental hygiene that are accredited by the Commission on Dental Accreditation of the American Dental Association when the professional continuing education course is held under the auspices of the school of dentistry.
 - (For CRP Courses): American Red Cross, American Heart Association, Health Institute, National Safety Council, EMS Safety Services or other such agencies approved by the Board.
 - National and State Associations and/or societies of all specialties in dentistry recognized under Georgia law
 - Veterans Administration Dental Department (VADD)
 - Armed Forces Dental Department (AFDD)
 - Georgia Department of Public Health (GDPH)
 - American Medical Association (AMA)
 - National Medical Association (NMA)
 - Hospitals accredited by the Joint Commission on Accreditation of Hospital Organizations (JCAHO).
- 🕒 At least thirty (30) hours of the minimum requirement (40 Hours) shall be clinical courses in the actual delivery of dental services to the patient or to the community.

- 👤 Four (4) credit hours for successful completion of the in-person CPR course required by Georgia law may be used to satisfy continuing education requirements per renewal period. This requirement may be satisfied by successful completion of an in-person Basic Life Support (BLS) or Advanced Cardiovascular Life Support (ACLS) course.
- 👤 One (1) hour of the minimum requirement shall include the impact of opioid abuse, proper prescription writing, and/or the use of opioids in dental practice.
- 👤 Effective on and after January 1, 2022, one (1) hour of the minimum requirement shall include legal ethics and professionalism in the practice of dentistry, which shall include, but not be limited to, education and training regarding professional boundaries; unprofessional conduct relating to the commission of acts of sexual intimacy, abuse, misconduct, or exploitation with regard to the practice of dentistry; legislative updates and changes to the laws relating to the practice of dentistry and rules, policies, and advisory opinions and rulings issued by the Board; professional conduct and ethics; proper billing practices; professional liability; and risk management.

Criteria for receiving credit for attending an approved continuing education course:

1. Credit hours are not retroactive or cumulative. All credit hours must be received during the two (2) year period to which they are applied.
2. One credit hour for each hour of course attendance will be allowed.
3. Only twelve hours of credit will be accepted per calendar day.
4. Effective January 1, 2008, at least twenty (20) of the required forty (40) hours of credit must be acquired in person at an on-site course or seminar; you are not allowed to acquire all CE hours through on-line courses, electronic means, journal studies, etc.
